IF THE VEHICLE IS NOT ELIGIBLE FOR THE PLAN OR TERM CHOSEN, THIS LIMITED WARRANTY IS VOID. **YOU UNDERSTAND THAT THIS WARRANTY IS BEING PROVIDED BY CORNERSTONE DEALER SERVICES AND EDELBROCK CORPORATION ASSUMES NO LIABILITY WHATSOEVER IN CONNECTION WITH THIS WARRANTY.**

Limited Warranty

WHO IS COVERED

Warranty obligations are limited to the owner of the vehicle (named on the Declaration Page of this Contract) in which the Edelbrock SUPERCHARGER Kit is installed. This warranty is not transferable to a second owner and is secondary to all other warranties and any manufacturers' recall that may be in effect. The term Kit OR SUPERCHARGER as used in this warranty applies to EDELBROCK SUPERCHARGER KIT, PART NUMBER 1580, 1581, 1583, 1585, 1587, 1590, 1591, 1598, 1599.

WARRANTY TERM

The contract term shall be the months/miles selected on the declaration page of this contract, whichever occurs first. The term of months shall be counted from the vehicle's original in-service date as determined by the manufacturer of the vehicle, or by OASIS, or by GMVIS, and the mileage shall be measured from actual miles on the vehicle odometer at time of purchase. The coverage under this contract will only be activated provided you submit the contract purchase price, warranty registration card and other applicable documentation to Cornerstone Dealer Services within THIRTY (30) days of the installation date.

WARRANTY ACTIVATION

In order to activate the coverage under this warranty you must return the front page of this warranty registration along with your paid service order installation receipt (which includes your vehicle identification number (VIN)) along with a check for the appropriate price (shown on the declaration page of this contract) to Cornerstone Dealer Services, PO Box 680783, Houston TX 77268-0783, within THIRTY (30) days of the service order installation date. If the purchase price listed above and other stated items are not received within THIRTY (30) days of installation, this contract is not valid. Make a photocopy of this document before sending.

WARRANTY COVERAGE

When a Kit is correctly and completely installed by a certified Ford, General Motors, or Chrysler automotive dealership, an EDELBROCK certified installer, or by an automotive service technician certified by the Institute for Automotive Service Excellence (ASE) at an automotive repair facility with a valid business license, on an eligible, legally registered and licensed vehicle, we will cover the repair and/or replacement of failed components, as specified below, during the term of this warranty provided you follow the activation procedure listed above, as solely determined by Cornerstone Dealer Services.

Engine Components:

Covered: Pistons, piston rings, piston pins, crankshaft and bearings, connecting rods and bearings, camshafts and bearings, timing chain and gears, intake/exhaust valves and seals, valve springs, oil pump, push rods, rocker arms, rocker arm shafts, and lifters, SUPERCHARGER and Supercharger kit components. If a failure of any of the above parts damages either the engine block or cylinder heads, a remanufactured long block assembly will be provided up to the maximum coverage of \$5000.00.

Non-Covered: Any engine components not specifically listed, including but not limited to, electrical components, seals & gaskets, polished finish on SUPERCHARGER – as well as parts, filters, fluids etc., that are required to be replaced as a part of your vehicle's normal maintenance schedule as published by the manufacturer.

Transmission Components:

Covered: All internally lubricated parts within the transmission.

Non-Covered: Failure of related parts external to the transmission which may cause a transmission claim including, but not limited to, electrical components, seals & gaskets, transmission coolers, levers, controls, etc.

Rear Axle Components:

Covered: Rear axle, ring gear, drive pinion, pinion shaft, side gears, bearings, bearing cap, washers, slinger, axle shaft, housing and housing cover.

Non-Covered: Seals and Gaskets

LIMITS OF LIABILITY

CORNERSTONE'S MAXIMUM LIABILITY PER COVERED VEHICLE UNDER THIS WARRANTY IS LIMITED BASED UPON THE PLAN SELECTED AS FOLLOWS:

SILVER IS LIMITED TO \$9,000.00 WHICH REPRESENTS THE TOTAL OF THE INDIVIDUAL COMPONENT GROUP'S LIABILITY AS FOLLOWS: ENGINE COMPONENTS ARE COVERED TO A MAXIMUM OF \$5,000.00, TRANSMISSION COMPONENTS ARE COVERED TO A MAXIMUM OF \$2,500.00, AND REAR AXLE COMPONENTS ARE COVERED TO A MAXIMUM OF \$1,500.00.

GOLD IS LIMITED TO \$13,000.00 WHICH REPRESENTS THE TOTAL OF THE INDIVIDUAL COMPONENT GROUP'S LIABILITY AS FOLLOWS: ENGINE COMPONENTS ARE COVERED TO A MAXIMUM OF \$9,000.00, TRANSMISSION COMPONENTS ARE COVERED TO A MAXIMUM OF \$2,500.00, AND REAR AXLE COMPONENTS ARE COVERED TO A MAXIMUM OF \$1,500.00.

PLATINUM IS LIMITED TO \$19,000.00 WHICH REPRESENTS THE TOTAL OF THE INDIVIDUAL COMPONENT GROUP'S LIABILITY AS FOLLOWS: ENGINE COMPONENTS ARE COVERED TO A MAXIMUM OF \$15,000.00, TRANSMISSION COMPONENTS ARE COVERED TO A MAXIMUM OF \$2,500.00, AND REAR AXLE COMPONENTS ARE COVERED TO A MAXIMUM OF \$1,500.00.

A replacement Kit or component(s) that has been installed in accordance with our instructions, assumes the remaining warranty of the original (replaced) Kit. If a Kit or any of its component(s) is/are exchanged, the replacement becomes your property and the returned Kit or component(s) becomes our property. Component(s) provided by us to fulfill our warranty obligation must be used in the product for which warranty service is claimed.

OBTAINING WARRANTY SERVICE

To obtain warranty service on your vehicle up-fitted with the SUPERCHARGER Kit, the vehicle must have an operational and accurate odometer and have maintenance services performed at the intervals as stated in the Ford Motor Company's vehicle maintenance schedule, General Motors (GM) vehicle maintenance schedule, either at a Ford dealership, GM dealership or commercial maintenance center. You must present these invoices in the event of a warranty claim; therefore, you must retain the maintenance receipts for your records. Such receipts must be on Licensed Repair Facility forms – hand written receipts will not be accepted.

You must submit copies of the following documents with your warranty claim: (a) your warranty registration form, (b) the receipt showing installation of the SUPERCHARGER by a certified Ford or GM Automotive Technician or ASE automotive service technician OR Edelbrock certified installer, and (c) all requested vehicle maintenance records.

CLAIMS PROCEDURES

When you present the Administrator with a valid, properly documented warranty claim during the Warranty Period, we will replace the defective component(s) by this warranty. We reserve the right to improve or modify the SUPERCHARGER assembly in accordance with Edelbrock's current production specifications.

1. If a warranted component has failed, please contact us immediately at 1-800-682-9761.
2. Prevent further damage – you should use all reasonable means and precautions to protect your vehicle from further damage. This Contract will not cover damage caused by not securing a timely repair of the failed component.
3. You may take your vehicle to any Licensed Repair Facility. However, Cornerstone Dealer Services reserves the right to move the vehicle to a Repair Facility of our choice.
4. Instruct the Repair Facility that they must obtain an authorization number from us prior to proceeding with repairs. The amount so authorized is the maximum that will be paid. Any additional exception amounts need prior approval.
5. You must authorize the Repair Facility to tear down the component for inspection before we authorize repair or replacement of a failed component covered by this warranty. If the failed component is not covered under this warranty, the tear down and subsequent repair or replacement costs will be solely your responsibility.
6. After you contact us, please review with the Repair Facility the components that will be covered for this claim.
7. An ASE certified Repair Facility must complete the repair or replacement based on the written estimate they provide to us. We base labor rates for repair or replacement services on All-Data labor time guides.
8. We will pay the Repair Facility directly or reimburse you for the cost of authorized repairs performed on your vehicle. All repair orders and necessary documentation must be submitted to Administrator within THIRTY (30) days to qualify for payment.

YOUR FAILURE TO CONTACT US AND RECEIVE AN AUTHORIZATION NUMBER BEFORE ANY REPAIR WORK IS PERFORMED WILL INVALIDATE YOUR WARRANTY CLAIM.

EXCLUSIONS/LIMITATIONS/WARRANTY DISCLAIMER

TO THE EXTENT PERMITTED BY LAW, THIS WARRANTY AND ITS REMEDIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES AND CONDITIONS, WHETHER ORAL OR WRITTEN, STATUTORY, EXPRESS OR IMPLIED. AS PERMITTED BY LAW, CORNERSTONE DEALER SERVICES SPECIFICALLY DISCLAIMS ALL EXPRESS, STATUTORY OR IMPLIED WARRANTIES, INCLUDING, WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND WARRANTIES AGAINST HIDDEN OR LATENT DEFECTS. IF CORNERSTONE DEALER SERVICES CANNOT LAWFULLY DISCLAIM ANY STATUTORY OR IMPLIED WARRANTIES THEN TO THE EXTENT PERMITTED BY LAW, ALL SUCH WARRANTIES SHALL BE LIMITED IN DURATION TO THE WARRANTY PERIOD AND THE WARRANTY COVERAGE DESCRIBED HEREIN.

THIS WARRANTY COVERS ONLY DEFECTS IN OUR MATERIALS OR WORKMANSHIP, AND DOES NOT APPLY TO THE ORIGINAL EQUIPMENT MANUFACTURER (OEM) EXTERIOR ENGINE COMPONENTS, IGNITION, FUEL SYSTEM, OR DAMAGE RELATED TO OR ARISING FROM:

USE OF FUEL WITH OCTANE RATING LESS THAN 91 (R+M)/2.

IMPROPER INSTALLATION, ABNORMAL OPERATION, ABUSE, NEGLIGENCE, LACK OF MAINTENANCE OR LACK OF FLUIDS, OR DAMAGE RESULTING FROM A COLLISION. OPERATION OF SUCH AN IMPAIRED VEHICLE WILL VOID THIS WARRANTY. THE VEHICLE OWNER IS RESPONSIBLE FOR ENSURING NO FURTHER DAMAGE OCCURS ONCE A PROBLEM HAS OCCURRED.

COVERED COMPONENTS BEING TAMPERED WITH OR ALTERED FROM FACTORY SPECIFICATIONS (OEM OR EDELBROCK) INCLUDING, BUT NOT LIMITED TO, THE REMOVAL OF THE SUPERCHARGER DRIVE PULLEY, FOR ANY REASON, AS EVIDENCED BY THE TAMPER PROOF LABEL.

DAMAGE OR ABUSE RELATED TO OVERLOADING, PCM RECALIBRATION, MISUSE, NEGLIGENCE, ROAD CONDITIONS, OVERSIZED TIRES, AND OTHER NON-EDELBROCK APPROVED MODIFICATIONS.

PARTICIPATING IN OR PREPARATION OF THE VEHICLE FOR RACING (ON A TRACK OR OTHERWISE), FIRES, FLOOD, RIOTS, ACTS OF WAR OR TERRORISM, THEFT, VANDALISM, NATURAL DISASTERS, PHYSICAL DAMAGE, CONSEQUENTIAL DAMAGE AND ACTS OF GOD ARE NOT COVERED.

THIS IS NOT A PERFORMANCE WARRANTY. IT DOES NOT COVER ANY VEHICLE IN WHICH THE KIT IS INSTALLED. IT IS A WARRANTY COVERING THOSE SPECIFIC COMPONENTS LISTED UNDER WARRANTY COVERAGE. EXCEPT AS PROVIDED IN THIS WARRANTY AND TO THE EXTENT PERMITTED BY LAW, CORNERSTONE DEALER SERVICES IS NOT RESPONSIBLE FOR DIRECT, SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL, OR PUNITIVE DAMAGES RESULTING FROM ANY BREACH OF WARRANTY OR CONDITION, OR UNDER ANY OTHER LEGAL THEORY INCLUDING, WITHOUT LIMITATION, LOSS OF REVENUE, LOSS OF ACTUAL OR ANTICIPATED PROFITS (INCLUDING LOSS OF PROFITS ON CONTRACTS), LOSS OF THE USE OF MONEY; LOSS ANTICIPATED SAVINGS; LOSS OF BUSINESS; LOSS OF OPPORTUNITY; LOSS OF GOODWILL; LOSS OF REPUTATION; LOSS OF EARNINGS; PERSONAL DAMAGES; PERSONAL INJURY INCLUDING DEATH; PERSONAL EXPENSES (FOOD, ROOM, MEDICAL, DENTAL); RENTAL VEHICLE EXPENSES; TOWING; STORAGE OR ANY OTHER LOSS OR DAMAGE HOWSOEVER CAUSED INCLUDING THE REPLACEMENT OF THE VEHICLE ON OR WHICH THE SUPERCHARGER IS INSTALLED OR OTHER PROPERTY.

CONSUMER PROTECTION LAWS

This warranty is valid only in the United States and Canada. Some states and provinces do not allow the exclusion or limitation of certain damages or the duration of implied warranties or conditions so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights that vary by state or province. The laws of the State of Texas will govern this warranty. Any action brought to enforce or interpret this warranty shall occur only in a court of the State of Texas or in U.S. District Court for the South Eastern District of Texas.

MISCELLANEOUS

NEITHER RESELLER NOR ITS EMPLOYEE, OR ANY EMPLOYEE OF EDELBROCK IS AUTHORIZED TO MAKE ANY MODIFICATION, EXTENSION, OR ADDITION TO THIS WARRANTY. EDELBROCK RESERVES THE RIGHT TO MODIFY THIS LIMITED WARRANTY AT ANY TIME. HOWEVER, ANY SUCH MODIFICATION WILL NOT ALTER THE WARRANTY CONDITIONS APPLICABLE AT THE TIME OF SALE.
